## RE: ARTICLE "CENTRES IN BANGLADESH HAVE BECOME MONEY MINTING MACHINES"

Dear Sirs,

- 1 We refer to the article" Centres in Bangladesh Have Become Money Minting Machines" posted on the TWC2 website at <a href="http://twc2.org.sg/2013/09/22/">http://twc2.org.sg/2013/09/22/</a>
- We share your concerns on the well being of construction workers. For the built-environment sector to have a sustained pool of workers, the well being of the workers need to be taken care of.
- As explained in our recent briefing to TWC2 on 4 Apr 2013, it is essential that every construction worker acquire the relevant trade skills and safety knowledge to work in the construction industry. This is essential to safeguard the health and safety of the workers, safety of buildings and infrastructure, and also public safety.
- Over the last few years, BCA has expanded the range of construction trades offered by the appointed Overseas Testing Centres (OTCs) from 7 to 29 trades. This facilitates the training and skill certification of workers in relevant trades so that they would be deployed to work on construction sites in Singapore. In the latest 2013 survey conducted by BCA, more than 70% of the relatively new construction workers were being deployed by employers in the directly relevant and related trades they were trained in. As shared with you on 4 Apr 2013, construction workers who are deployed in the trade they were trained in draw higher wages.
- We note that the malpractices quoted in the article in the TWC2 website occur in the source countries. BCA has been having conversations with the Bangladesh Ministry of Expatriates and Welfare Employment (MOEWE) and the Bangladeshi Embassy in Singapore on related matters. We understand that the local authorities are looking into this.
- Referring to the online article, do allow us to correct the following factual inaccuracies:-.
